TERMS OF USE

AGREEMENT TO TERMS

These Terms of Use constitute a legally binding agreement made between you, whether personally or on behalf of an entity (“you”) and BootUp PD (“Company”, “we”, “us”, or “our”), concerning your access to and use of the bootuppd.org website as well as any other media form, media channel, mobile website or mobile application related, linked, or otherwise connected thereto (collectively, the “Site”). You agree that by accessing the Site, you have read, understood, and agreed to be bound by all of these Terms of Use. IF YOU DO NOT AGREE WITH ALL OF THESE TERMS OF USE, THEN YOU ARE EXPRESSLY PROHIBITED FROM USING THE SITE AND YOU MUST DISCONTINUE USE IMMEDIATELY.

Supplemental terms and conditions or documents that may be posted on the Site from time to time are hereby expressly incorporated herein by reference. We reserve the right, in our sole discretion, to make changes or modifications to these Terms of Use at any time and for any reason. We will alert you about any changes by updating the “Last updated” date of these Terms of Use, and you waive any right to receive specific notice of each such change. It is your responsibility to periodically review these Terms of Use to stay informed of updates. This licensing approach is intended to expand equitable access while preserving the integrity and intended use of the curriculum.

USER REPRESENTATIONS

By using the Site, you represent and warrant that: (1) You are at least eighteen (18) years of age and are using the Site solely as an educator, school official, administrator, parent, or authorized adult user; (2) The Site is not intended for direct use by children under the age of thirteen (13), and children under 13 may not create accounts or provide personal information directly to BootUp; (3) If student access to curriculum is provided, such access must be facilitated and controlled by a school or authorized educator, and not directly by the child; (4) If you are using the Site on behalf of a school or district, you have authority to act on its behalf and to provide any required consents under FERPA and COPPA; (5) You will not provide student data unless authorized under applicable law and institutional policy.

Users agree not to upload or share student data unless authorized under FERPA and applicable district policies. BootUp implements reasonable administrative, technical, and physical safeguards to protect student data.

PROHIBITED ACTIVITIES
